CONSISTENCY SINGLES CONDITIONS OF PLAY

- This event is open to all Members of Camden Men's Bowling Club
- Handicaps for this event will be decided by the Selectors.
- IT IS A CONDITION OF ENTRY FOR THIS EVENT THAT YOU MAKE YOURSELF AVAILABLE TO BE A MARKER. IF YOU ARE NOMINATED TO MARK AND ARE UNABLE TO DO SO IT IS YOUR RESPONSIBILTY TO FIND A REPLACEMENT. IF YOU ARE NOT PREPARED TO MARK, PLEASE DO NOT ENTER THIS EVENT.

SCORING

- 1. The closest bowl scores 4 points, the second closest bowl scores 3 points, the third closest bowl scores 2 points and the fourth closes bowl scores 1 point
- 2. Should 2 or more bowls be the same distance from the jack, the total score for these bowls is halved for each player
- 3. If a player kills an end, his opponent scores 10 points for that end
- 4. For any end that is played, all 10 points must be allocated to one or other of the players according to 1. Above
- 5. If after the completion of the scoring for an end and one player only reaches or exceeds 150, than that player will be declared the winner
- 6. If after completion of scoring for an end and both players reach or exceed 150, than the player with the highest score will be declared the winner
- 7. If both players reach the same score greater than or equal to 150, an extra end will be played. This will continue until at the completion of scoring for an extra end, one player is in advance of the other

PLACEMENT OF JACK

- When the Jack is rolled to position the "Marker" shall centre the Jack on the centre line on a small washer provided by the club.
- During play if the Jack is moved off the washer <u>at any stage</u> the Marker shall <u>place</u> the Jack back on the washer.
- If during the "End" a bowl displaces the "Jack" from the washer and impedes the REPLACEMENT of the "Jack" on the washer THAT BOWL SHALL BE MOVED AS SHORT A DISTANCE AS POSSIBLE BY THE MARKER TO ENABLE THE REPLACEMENT OF THE "JACK" BACK ON THE WASHER.
- The washer should never be moved from its original position during the "End".
- Touchers shall still be marked with chalk / spray.

GENERAL CONDITIONS

- Controlling body for the event is the match committee present
- All decisions made by the controlling body regarding this competition shall be final
- The controlling body shall have the right to change the conditions of play to ensure there is a finish to the event by a suitable date.
- This event is to be played to the rules and conditions of Bowls Australia and Bowls N.S.W except as decided by the controlling body.

PLAY OR FORFEIT RULE

This event is to be played under the Club's "play or forfeit" rule i.e. play on or before the due date. However, where circumstances prevail a bowler or team can request the game be played before the next scheduled round. If mutual agreement is reached the player / team requesting the extension must notify the Bowls Organiser. (If this is not done the game will be invalid) If under any circumstances the game is not completed by the scheduled date (i.e., the next round) the player / team requesting the extension forfeits the game and notifies the Bowls Organiser.
