## SENIOR SINGLES CONDITIONS OF PLAY

- This is an open gender event for those turned 60 before 25 May 2024.
- This event will be sectional and knockout.
- Sections to be filled by random draw by match committee, Sections with 3 players shall be played 17 shots up. Sections with 2 players shall be played 25 shots up.
- In the event sections needs to be balanced because of withdrawals or forfeits the Match Committee has the right to make such changes.
- If there are any withdrawals or forfeits after the draw has been completed the match committee has the right to rearrange the sections that have only two people in a section to a three-person section. Changes will be made starting from the top of the draw in all cases.
- Section winners will enter a random draw for remaining matches. Which shall be played 25 shots up.
- After the first game in a three-person section the marker of that game is entitled to have a practice on that rink before the commencement of the next round.
- Sectional allocation of points shall be Win 3 points, Tie 1 point, Loss 0 points. Section standings refer to General Conditions of play 38.2 page21 (points then Margin)
- Cards called 20 minutes before, and rollups completed by start time.
- One rollup each way.
- 4 bowl singles
- Dead Ends to be replayed.
- There is no order of precedence for this event.
- IT IS A CONDITION OF ENTRY FOR THIS EVENT THAT YOU MAKE YOURSELF AVAILABLE TO BE A MARKER. IF YOU ARE NOMINATED TO MARK AND ARE UNABLE TO DO SO IT IS YOUR RESPONSIBILTY TO FIND A REPLACEMENT. IF YOU ARE NOT PREPARED TO MARK, PLEASE DO NOT ENTER THIS EVENT.
- NOMINATED MARKERS WHO DON'T TURN UP OR FIND A REPLACEMENT WILL BE INEIGIBLE FOR THE SAME CHAMPIONSHIP EVENT THE FOLLOWING YEAR.


## UNABLE TO PLAY

- All matches are to be played under the Club's "play or forfeit" rule i.e. play on or before the due date, however where circumstances prevail a bowler can request the game be played before the next scheduled round. If mutual agreement is reached the player requesting the extension must notify the Bowls Organiser. (if this is not done the game will be invalid) If under any circumstances the game is not completed by the scheduled date (i.e. the next round) the player requesting the extension forfeits the game and notifies the Bowls Organiser.


## GENERAL CONDITIONS

- Controlling body for the event is the match committee present.
- All decisions made by the controlling body regarding this competition shall be final.
- The controlling body shall have the right to change the conditions of play to ensure there is a finish to the event by a suitable date.
- This event is to be played to the rules and conditions of Bowls Australia and the Bowls N.S.W except as decided by the controlling body.
