Scheduled dates will be Saturday's 18th, 25th October am + pm if required. (Spare day 8 November)

Final's Day for Minor, C and Major Singles is scheduled for 9th November.

Please nominate M if you wish to play in the Minor Singles i.e. write M beside your name.

The selectors will determine those eligible for the C Singles.

There is no order of precedence for this event.

Cards called 20 minutes before agreed start time., and rollups completed by start time.

If you have any concerns or queries, please approach one of your Match Committee as soon as possible.

2025 – 2026 Camden BC OPEN MINOR & C SINGLES CONDITIONS OF PLAY

- As per CMBC Regulations 16.2.3.
 - The final decision on eligibility for the ‘C’ singles will be made by the Selectors. Note: In some circumstances, due to age, health, playing ability or other relevant reason, application may be made in writing to the selectors for inclusion in this event. These applications shall be reviewed by both Selectors and the Board, and a decision made.
 - All applications shall be kept on record.
 - All applications must be made before entries close.
- This event may be conducted as Sectional 17 up or Knockout 21 up.
- The Match Committee may accept late entries to fill a vacant position in the draw caused by: A withdrawal up until 24 hours prior to the scheduled start time.
- Players may practice up to (30) minutes prior to the scheduled start time if a rink is available.
- 4 bowl singles
- One rollup each way rollups completed by start time.
- WINNER First to or exceed
- Dead Ends to be replayed.
- IT IS A CONDITION OF ENTRY FOR THIS EVENT THAT YOU MAKE YOURSELF AVAILABLE TO BE A MARKER. IF YOU ARE NOMINATED TO MARK AND ARE UNABLE TO DO SO IT IS YOUR RESPONSIBILITY TO FIND A REPLACEMENT. IF YOU ARE NOT PREPARED TO MARK PLEASE DO NOT ENTER THIS EVENT.
- NOMINATED MARKERS WHO DON'T TURN UP OR FIND A REPLACEMENT WILL BE INELIGIBLE FOR THE SAME CHAMPIONSHIP EVENT THE FOLLOWING YEAR

UNABLE TO PLAY

- There is no order of precedence for this event. any reason.
- All matches are to be played under the Club's "play or forfeit" rule i.e. play on or before the due date. However, where circumstances prevail a bowler or team can request the game be played before the next scheduled round. If mutual agreement is reached the player / team requesting the extension must notify the Bowls Organiser. (If this is not done the game will be invalid)
If under any circumstances the game is not completed by the scheduled date (i.e. the next round) the player / team requesting the extension forfeits the game and notifies the Bowls Organiser.

GENERAL CONDITIONS

- Controlling body for the event is the match committee present
- All decisions made by the controlling body regarding this competition shall be final
- The controlling body shall have the right to change the conditions of play to ensure there is a finish to the event by a suitable date.
- This event is to be played to the rules and conditions of Bowls Australia, Bowls NSW except as decided by the controlling body
