BOWLS LAW: The third of Team A plays his bowl then the third of Team B approaches the mat and turns it over before playing. The third of Team A objects claiming the mat has been moved. Is he correct?

Answer: No. Under Law 6.2.6 a player may turn the mat over to gain better purchase but may not move it from its original position.
