BOWLS LAW: The skipper of team A drives at the jack which hits the face of the bank and rebounds up the rink. The Skipper of team B claims that as a rebounding bowl is dead (Law 17.1.2), then a rebounding jack is also dead. The skipper of team A claims that the jack should be placed in the ditch below where the jack hit. Who is correct?

Answer: Neither. Under Law 21.1 the end will continue if the jack rebounds up the rink. The jack stays where it finishes provided it is not less than 20 meters from the mat. Appendix Law B.4.2
