<u>BOWLS LAW:</u> A bowl which has been a toucher in the previous end, is delivered with its chalk mark still on the bowl. It does not touch the jack, but the chalk mark is not removed. As a result of play, several bowls later this bowl is forced into the ditch. The skip of Team A wants to call the bowl live as more than two bowls have been delivered since it had come to rest meaning the chalk mark is now legitimate. The skip of Team B wants the bowl removed as it did not touch the jack and even though it is marked the mark is not legal. Who is correct?

Answer: The skip of Team B. Under law 15.5 the third of Team A should have removed the mark. Under Law 17.1.1 & 17.3 and 17.4 the bowl is dead and should be removed from the rink.
