<u>BOWLS LAW:</u> The third of Team A takes his stance on the mat with his toes protruding over the front edge and his back foot off the mat. He delivers his bowl without moving his back foot on to the mat. The third of Team B calls him for foot faulting. Is he correct?

Answer: No. Under Law 7.1 the player must have one foot on or over the mat at the moment of delivery. As long as the back foot is over the mat it is a legal delivery.
