BOWLS LAW: Two players are preparing for their two trial ends before commencing their singles game. Player A sets out six bowls, three from two different sets of bowls saying that he is allowed to trial with different bowls. Player B asks the marker if this is allowed as they are playing with only four bowls. The marker says he doesn't know. What should they do?

Answer: the marker should call the umpire who informs player A that he may trial with two sets of bowls but as they are playing with four bowls he can only use four bowls in the trial ends. Law 5.1.4 He may use two from each set or three from one and one from the other.
